IBC Update

Background:

Future Enterprises Limited (FEL) has issued secured non-convertible debentures by way of private placement, under various Debenture Trust Deeds executed between FEL and Axis Trustee Services Limited (ATSL). The Hon'ble National Company Law Tribunal, Mumbai Bench, Court-III vide its order no. C.P. No. 513/IBC/MB/2022 dated **27.02.2023** passed an order for commencement of Corporate Insolvency Resolution Process of Future Enterprises Limited.

As per provisions of IBC, the Interim Resolution Professional has also made public announcement on **08.03.2023** to call for the submission of Claims from the creditors of FEL on or before **21.03.2023**.

In response to the Public Announcement dated 08.03.2023 by the IRP, ATSL, has filed the claims with the IRP in respect of debenture holders under each issuance and as per the debenture issues as per above mentioned list on 21.03.2023. The said claims are being filed in prescribed Form C, in capacity of a Debenture Trustee, as per the provisions of Section 7 read with Section 21 (6A) (a) of Insolvency and Bankruptcy Code, 2016. While calculating the claims, amount of NCDs outstanding under each ISIN, interest at coupon rate, penal interest / default interest (if any) etc. as per Term Sheet, have been considered. Further, emails has been sent to all debenture holders regarding claim calculations. Latest Beneficial Position (Benpos) status received from the RTA as on 10.03.2023 has also been considered.

In view of the above, we reiterate that there is no need for debenture holders to file claims separately. Status of the same will be updated from time to time.

It is necessary for each of the debenture holders to ensure that their information is correctly recorded in the list of debenture holders (BENPOS). We, therefore, request debenture holders to kindly update their Email IDs and check their spellings, domain name, and Bank account details registered with Depository Participants (DP) (through Client Master List).

If your Email ID is already registered, request your DP i.e., NSDL / CDSL to enable the Email D/L Flag Option to get your email ID reflected in BENPOS to receive all communications in Electronic Form.

If email ID is not registered- register or update the same with your DP i.e. NSDL / CDSL.

Contact your DP-NSDL/CDSL if above steps are taken but still emails are not being received.

Further it is also requested to check correctness of bank account details and addresses.

Please note that, to access the documents related to CIRP, the Debenture Holders have been provided with a unique login credential by the Resolution Professional's (RP) team for accessing the Virtual Data Room. The login details have been sent to the registered email ID from Dcirrus.
