<u>Chronology of Events – Default in NCDs aggregating to ₹100 crore issued by Madhya</u> <u>Pradesh Financial Corporation (MPFC)</u>

ATSL, acting as Bond Trustee under the Bond Trust Deed dated January 5, 2015, for the 9.20% unsecured, redeemable, non-convertible bonds (ISIN INE348F08043) aggregating to ₹100 crore issued by Madhya Pradesh Financial Corporation (MPFC), received an email from the issuer dated November 20, 2024. In this communication, MPFC confirmed that interest payments up to the due date of November 19, 2024, had been made to all bondholders, and principal redemption of ₹3.08 crore was paid to 32 bondholders.

However, payment of ₹36.92 crore to 8 remaining bondholders were pending, to be made from funds sanctioned by the Government of Madhya Pradesh. ATSL noted that the non-payment of principal constituted an Event of Default under Clause 8.2 of the Bond Trust Deed and initiated enforcement action against the issuer.
