Sub: ATSL letters dated October 1, 2021 to UCO Bank, Reserve Bank of India and Srei Equipment Finance Limited (SEFL) (Company/Issuer) in relation to utilization of funds by Banks attached herewith as **Annexure A**.

Dear Sir,

We refer to the captioned subject and the various newspaper reports / articles regarding utilization of funds by banks, based on which we understand that lender banks are adjusting/have adjusted Rs. 3,000 Crore from SEFL's cash flows against the loan dues.

As you are aware, we are the debenture trustee for Non-convertible debentures (NCDs) issued by SEFL, under various ISINs and Debenture Trust Deeds as more particularly described in **Annexure B** hereto.

The NCDs are secured by way of receivables of SEFL in our favour as the Debenture Trustee. We apprehend that the lender banks are/were operating the Trust and Retention Account (TRA) and utilizing the funds unilaterally without intimation/consultation with us, which is prejudicial to the interest of the debenture holders.

While we have separately written to UCO Bank and RBI for their necessary action, we hereby request you to share all details and information about the utilization of the funds by banks from the Trust and Retention Account till date.

In the interest of the Debenture Holders, we also request you to share the details of any audit/inspection conducted over the books of accounts and receivables of Srei Equipment Finance Limited pertaining to this matter for our reference.

As you will recall, we had raised the aforementioned concerns in the 1<sup>st</sup> COC meeting conducted on 2.11.2021 but the concerns were not recorded in the minutes. Further, during discussions in the 2<sup>nd</sup> COC we were advised that the minutes of the 1<sup>st</sup> COC meeting would be revised/rectified to incorporate the mention. However, we are yet to receive the revised/rectified minutes and the response to our queries. We urge you to refer to the recordings of the meetings for your convenience.

In light of the foregoing and in the interest of the debenture holders including large number of retail investors and individuals, provident funds and gratuity, we seek your urgent intervention in the matter and necessary advice and guidance at the earliest preferably within 7 days failing which we would be constrained to seek other remedies including appropriate legal action.
